

MILLETTEYPE FOUNDRY END-USER LICENCE AGREEMENT (EULA)

This End-User Licence Agreement (“AGREEMENT” or “LICENSE”) is a legal agreement between you (“YOU” or “LICENSEE”), either an individual or a single entity) and Milletteype Foundry for the Milletteype Foundry Font Software (“FONTS”) product(s) accompanying this Agreement, which include computer software and may include associated media, printed materials, and “online” or electronic documentation.

By downloading, installing, or using the Fonts, you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, do not download, install, or use the Fonts.

1. GRANT OF LICENCE

1.1 USE

Milletteype Foundry grants a contract under the terms and conditions of this Agreement, providing a non-exclusive license. Milletteype Foundry retains all rights to the downloaded typeface. The license is non-transferable, prohibiting resale, transfer (whether free or paid), in whole or in part, and temporary transfer of the downloaded typeface. The licensee is obligated not to distribute the typeface files in any manner. Additionally, this agreement is non-terminable, and the buyer cannot request a refund based on discontinuing the use of the typeface.

1.2 NUMBER OF USERS

The licence allows usage by the number of users specified in your purchase or download order. You may not exceed the authorised number of users.

1.3 EMBEDDING

You may embed the Fonts into electronic documents for personal or internal business use. However, you must take reasonable steps to ensure that recipients of such documents cannot extract or use the embedded Fonts for purposes other than viewing and printing.

1.4 BACKUP COPIES

You may make a reasonable number of copies of the Fonts for backup and archival purposes, provided that any copy must contain the original copyright and trademark notices.

2. OWNERSHIP

The Fonts are the intellectual property of Milletteype Foundry and are protected by copyright and other intellectual property laws. The structure, organisation, and code of the Fonts are valuable trade secrets and confidential information of Milletteype Foundry.

If the Licensee’s work, in which the Font Software is utilised, includes a colophon or credits section, it is mandatory to acknowledge and mention the name of the Font Software and the Designer.

This agreement does not transfer the copyright of the Font Software’s design to the Licensee; instead, it grants the Licensee the rights to use the fonts.

3. RESTRICTIONS

You, or any third party, are not allowed to :

- Modify, edit, adapt, translate, create derivative works based on the Fonts, reverse-engineer the Fonts, develop the Fonts in another language, commission other contractors to make modifications.
- You may alter the typeface outlines for logotypes. Such modifications may not be inserted into the Font Software, its copies or used in any digital font file formats. For any customizations of the Font Software please contact Milletteype Foundry.
- Sell, rent, lend, give, distribute, make available to the public, sublicense the licence or the fonts files as a whole or in parts.
- Open in a font editor, convert them to web fonts by your own or using a conversion service.
- Change the format or name of the Fonts.
- Redistribute Font Software with other software packages or other means that make the raw fonts accessible to third-parties not covered by your licence.
- Embed the font in open-source software, commercial software, operating systems, electronic devices. You need a special licence/ permission for this.
- Store and/or serve the Fonts for the purposes of making them available via the internet, regardless of the format or technology used (such as git repositories).

YOU MAY NOT USE THE FONTS IN ANY MANNER THAT INFRINGES THE INTELLECTUAL PROPERTY RIGHTS OF MILLETTEYPE FOUNDRY OR ANY THIRD PARTY. WE PROHIBIT USES FOR POLITICAL PURPOSES, WAR, HATE SPEECH OR ANY USE THAT COULD HARM OR OFFEND OTHERS.

4. TERMINATION

This Agreement is effective until terminated. Your rights under this Agreement will terminate automatically without notice from Milletteype Foundry if you fail to comply with any term(s) of this Agreement. Upon termination, you must destroy all copies of the Fonts.

5. WARRANTY DISCLAIMER

The Fonts are provided “as is” without warranty of any kind. Milletteype Foundry does not warrant that the Fonts will meet your requirements or that the operation of the Fonts will be uninterrupted or error-free.

6. LIMITATION OF LIABILITY

To the maximum extent permitted by applicable law, in no event shall Milletteype Foundry be liable for any special, incidental, consequential, or indirect damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of or inability to use the Fonts.

8. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding between you and Milletteype Foundry regarding the Fonts and supersedes all prior or contemporaneous agreements, whether oral or written, relating to the Fonts.
